## **RIGHT TO REGULATORY ENFORCEMENT FAIRNESS**

The Consumer Financial Protection Bureau (CFPB) is committed to fair regulatory enforcement. If you are a small business under Small Business Administration standards, you have a right to contact the <u>Small Business Administration's National Ombudsman (SBA/ONO)</u> at 1-888-REGFAIR (1-888-734-3247) or <u>via email at ombudsman@sba.gov</u> regarding the fairness of the compliance and enforcement activities of the agency. Contacting the Ombudsman will not affect the CFPB's authority to investigate, enforce, or otherwise seek compliance as part of its ongoing responsibility to enforce Federal laws.

## NON-RETALIATION

As part of its commitment to fair regulatory enforcement, the CFPB reminds small businesses that they can exercise their right to raise concerns about compliance or enforcement activities without fear of retaliation.
